Hole diameter: 12.25", casing diameter: 9.625", casing weight and grade: 36ppf J55 LTC. Depth of 12.25" hole from 0' to 520'. Casing set from surface to 507'TVD/MD.

On 12/23/12 pumped 227 sks Type III Cement + 25#/sk Celloflake + 1% CaCl2 + 0.2% FL52A. Yield 1.38 cuft/sk. Mixed at 14.6 ppg. 56 bbls circ to surface. WOC 8 hours for surface casing.

Float collar at 463'. TOC at surface and BOC at 507'.

Tested BOP and casing 12/24/12. BOP pressure held to 3000# for 30 minutes. No pressure drop. Tested casing to 1500# for 30 minutes. No pressure drop. ✓

Started drilling out cement at 543'TVD/MD on 12/24/12.
