D. J. Simmons, Inc. proposes to Plug and Abandon the subject well using the following procedure:

- Move in well service unit and rig up.
- Nipple up BOP.
- Trip out of hole with tubing and BHA.
- Trip in hole with work string to make gauge run to perforations at 3627'
- Trip in hole with CIBP to set plug at 3590'+/-.
- Circulate hole and spot 150sx (178 cu ft) 15.8ppg cement on top of CIBP to bring cement to 3190'+/-.
- Pull tubing to 3190'+/-.
- Circulate to spot 9,400 gallons (223.8 bbls) inhibited water from 3190'+/- to 300'+/-.
- Trip out of hole with workstring laying down excess tubing to land at 300'.
- Circulate hole and spot 115sx (97.5 cu ft) 1.18 cu ft/sx 15.8 ppg cement from 300' to surface
- Cut off wellhead and casing strings to 4' below grade. Install plugged well marker and fill bell hole with 15.8ppg cement.



CONDITIONS OF APPROVAL

3. The following modifications to your plugging program are to be made:
