13. Describe Proposed or Completed Operations (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. While attempting to perform a mechanical integrity test, it was discovered that this well had been perforated from 438' - 453' and from 456' to 461' GL with a bridge plug set at approximately 518'. Coulthurst Management requests permission to drill out any bridge plugs in the well and set the packer at approximately 400' GL. The maximum injection pressure will be 87 psi. It was also discovered that there was no bradenhead on this well. Coulthurst proposes to weld a plate from the surface casing to the production casing and installing a bradenhead valve.
