Hole diameter: 6 1/8" production string diameter, 4 1/2" production string weight and grade: 11.6# SB80 LTC. Depth of 6 1/8" hole from 5792'MD to 9640'MD. Float shoe at 5672'MD and float collar at 5626'MD. Production liner set from 5469'MD to 9637'MD.

Set 16 external swellable casing packers for isolation of production string at the following depths: (1) 9397' (2) 9175' (3) 8945' (4) 8722' (5) 8456' (6) 8233' (7) 8009' (8) 7785' (9) 7520' (10) 7297' (11) 7029' (12) 6767' (13) 6504' (14) 6242' (15) 6021' (16) 5795'.
