Cement with 560 sks 65/35 Class B, 6% gel, 10#/sk gilsonite, 1/2#/sk flocele, 2% CaCl2 tailed by 125 sks Class B, 1/4#/sk flocele (1246 cu.ft.). Plug down @ 7:45 on 08/17/05. Circulate 70 bbls cement to surface. WOC. RD Halliburton. NU BOP. Pressure test casing & BOP to 1200 psi - ok.
