Benson- Montin-Greer Drilling will MIRU Llaves Well Service. RU Basin Wireline Co and run CBL from TD (7100') to cement top estimated @ 6544'. GIH with 2-3/8" tubing, set cement retainer @ 6875'. We will run a MIT - if the wells passes to JAECO satisfaction - they will release BMG from future liability. If the well fails the test, we will continue to plug and abandon the well per approved P&A procedure.
