Mesa Verde Recompletion

1/3/2013

Procedure:

1. MIRU service rig. TOOH and lay down current production tubing string.
2. Wireline set a 5-1/2" composite bridge plug @ 6,500' above the existing Dakota completion.
3. Run a GR/CCL/CBL correlation log. The GR will be used to pick formation tops and the CBL will be used to pick the TOC.
4. ND well head & NU frac valve. Pressure test frac valve and casing.
5. Complete the Mesa Verde formation.
6. Flow back well to clean-up.
7. RIH with wireline and set a composite bridge plug above top perf.
8. TIH with a mill and drill out the top composite plug. Flow test MV up the casing.
9. Drill out the CBP set above the DK @ 6,500' and clean out to PBTD @ 6810'
10. Flow test entire wellbore up the casing.
11. TIH and land production tubing.
12. Release service rig and turn over to production.
