C/O fill. POH w/DP. PU & run 5-1/2", 15.5#, J-55 pre-perf'd liner & set @ 3447' w/TOL @ 3072' (48' overlap). Perforations from 3314' - 3358' & 3141' - 3271'. Circ. thru 2-7/8" DP & 2-3/8" tbg jet string w/air, mist & foamer C/O fill. POH & LD DP. Changed rams in BOP. RIH w/112 jts 2-3/8", 4.7# J-55 tbg and set @ 3389 w/SN @ 3364' ND BOP. NU WH. RIH w/pump & rods. Spaced out. Load tbg & PT pump & tbg to 500 psi. OK. RD & released rig 8/31/05.
