Cemented stage 1 with 100 sx , 50/50 POZ + 2% gel + 6.25#/sk Gilsonite + 2% CaCl2 + 4% FL52 + 0.25 #/sk celloflake. Open & circulate thru DV tool. Circulate 10 sx to surface. Cemented stage 2 with LEAD 350 sx 35/65 POZ + 8% gel + 6.25 #/sk Gilsonite + 2% CaCl2 + 4% FL 52 + 0.25 #/sk celloflake and TAIL 100 sx 50/50 POZ + 8% gel + 6.25 #/sk Gilsonite + 2% CaCl2 + 4% FL52. No circulation. Ran temperature survey. TOC at 300'. On 6/16/98 pressure test casing to 1000 psi, ok.
