ii) The perforations are at 3798'-3819' (Pictured Cliffs) and 5440'-6100' (Mesaverde)

iii) Based on the 24 months ending May 2005, production will be allocated as follows

Liquid hydrocarbons: 0.00% Blanco Mesavrede & 0.00%, Pictured Cliffs

Natural Gas will be allocated : 97.89% Mesaverde and 2.11% Pictured Cliffs

Water 0% for both Pools

iv) The commingling will not reduce the value of the total remaining production.

v) Ownership the same in both pools.

Bureau of Land Management Conditions of Approval:

- 1) If this well is located in a Specially Designated Area (SDA), compliance with the appropriate seasonal closure requirements will be necessary.**
- 2) Pits must be lined with an impervious material at least 12 mils thick. The pit must be fenced on three (3) sides during workover operations and on the 4th side after the rig moves off location. Pits must be closed within 90 days of completion of the workover operations. Prior to closing the pit the liner must be cut off at mud level.**
