The APD for this well was just recently approved and as mentioned the well was originally proposed for completion in both the Basin Dakota and Basin Mancos. Upon futher review it has been determined that the Mancos will produce a greater volume of oil than gas and therefore it should be a 40 acre Angle Peak Gallup (oil). A new C-102 plat indicating acreage and configuration is enclosed for your files.
