It is intended to drill and complete the subject well in the Blanco Mesaverde (pool 72319), Basin Mancos (pool 97232) and the Basin Dakota (pool 71599). The production will be commingled according to Oil Conservation Division Order Number 12984-B. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production. The Bureau of Land Management has been notified in writing of this application.
