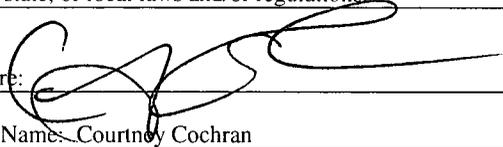
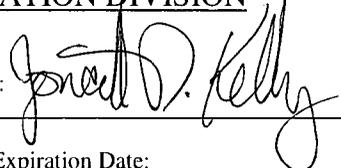

Natural gas dissipated to atmosphere so no clean-up action possible.
