LOGOS contacted Jim Lovato with the BLM on 12/04/12 at 8:40 AM and obtained verbal approval to move a rig to the Logos #1 to isolate water production from the lower Dakota.

LOGOS proposes to TIH with a Cast Iron Cement Retainer to shut off water from the lower Dakota perforation interval. The cement retainer will be set at 6428'. After setting the retainer, LOGOS will sting into the retainer and swab test the lower zones for fluid entry. The cement retainer will be left in place if the lower Dakota perforations are wet or do not contain hydrocarbons. The well will then be put back on production to test the total fluid volume on the well. If the well is still making high water volumes then a second cement retainer will be set at approximately 6230' so that the perforations below the retainer can be swab tested again. LOGOS will leave the CICR in place if the zone is wet or does not contain commercial volumes of hydrocarbons. After testing the zones, LOGOS will return the well to production with the pumping unit.
