Re-set a Model AD-1 packer with 20,000# of tension at 417' GL. Loaded the annulus and pressure tested to 500 ps for 30 min. Pressure test held OK. The test was witnessed by NMOCD on 3/4/13. Water will be injected into the Menefee formation by gravity from a surface production water tank. Before August 1, 2013 plates will be welded from the 8-5/8" surface casing to the 4-1/2" production casing and a 2" nipple and valve will be welded on the 8-5/8 casing for use as a bradenhead valve.
