This location has been archaeologically surveyed La Plata Archaeological Consultants. Copies of their report have been submitted directly to the USFS, Jicarilla Ranger District.

This APD is also serving as an application to obtain an access road and gas pipeline.

Required for this location is a 450-foot access road. This road will be built for either the Rosa 258A or the Rosa 189C; whichever is to be drilled first.

A pipeline tie of 104.6' will be required.
