TIH w/2-7/8" prod csg & landed @ 1300'. Installed baffle plate. Ran centralizers. M&P 60 sxs 12.5ppg GASBLOCK cmt. Cement to surface. WOC. ND BOP. Cut off tbg & installed WH. NU BOP. Ran CBL from surface to 1300'. Good CMT bond top to bottom. Tested BOP's. TIH w/1.25" tubing. Tagged cmt @ 1266'. Drilled plug & baffle plate - good CMT. C/O to 1436'. TIH w 1.25" tbg. Blow well down. Flow well to clean up. TOH w/tbg. ND BOP's. NU WH. Blew pump-out plug out of tbg @500 psi. Plug was out of tbg.
