Encana Oil & Gas (USA) Inc. (Encana) wishes to re-adjust the project area dedicated to the Lybrook I02-2308 01H well from 160 acres (N2S2 Sec. 2, T23N R8W) to 320 acres (S2 of Sec. 2, T23N R8W). Please see the following reasons for the re-adjustment to the 320 acre project area:

On October 12, 2012, Encana received BLM approval for the Application for Permit to Drill for the Lybrook I02-2308 01H well, with a 160 acre project area dedicated to the well in the Nageezi-Gallup Pool (Order Number 5339, Pool Code 47540).

Recently, the New Mexico Oil Conservation Division (OCD) has informed Encana of the applicability and interpretation of the Basin Mancos Gas Pool (Order Number 12984, Pool Code 97232), which applies to the Lybrook I02-2308 01H well (in the SE of Section 2, T23N R08W). Please also note that the Nageezi-Gallup Pool is also applicable to the Lybrook I02-2308 01H (in the SW of Section 2, T23N R8W). In order to accommodate for the differing spacing unit configurations and sizes for the aforementioned pools Encana wishes to increase the project area for this well to 320 acres.

Furthermore, Encana will also file with the OCD a Non-Standard Location Application for the penetration point in the Basin Mancos Gas Pool; a Non-Standard Proration Unit Application for the Nageezi-Gallup Pool and Basin Mancos Gas Pool; and a Downhole Commingling Application for the commingling of the two aforementioned pools. In addition, Encana will notify the appropriate parties pursuant to these applications.


