COPC received verbal approval from Troy Salyers (BLM) and Bill Hoppe (OCD) requesting approval to set the intermediate casing setting depth 200' shorter than planned because the bit had stopped work and they needed to pull out of the hole. The new setting depth for the intermediate casing will be 4653' (VD) / 4807' (MD). Cement will be adjusted on production string to ensure cement tie-back.
