Energen Resources would like to recomplate the existing West Lindrith Gallup Dakota pool. The existing perfs are from 7349'-7387' at 1spf & 7418'-21, 59'-61', 64'-7479' at 2spf, and the estimated new perforations are 6356'-6535' at 3 spf. A CBL will be run from around 7300' to surface to determine TOC. Then, perforate and fracture. Clean out to PBD, then return full production from all perforations.
