P&A procedures have been modified slightly to include a plug to properly abandon the MV interval on this well. Plans are now to D/O the CIBP set 3745', move downhole and set a new CIBP @ approx. 50' above the bottom shoe @ 4895', Run a CBL to Surface and then pump 100' cement on the CIBP for the MV isolation. Will then proceed with the plugging procedure approved with sundry dated 2/29/12. Verbal approval for this change was given by Bill Hoppe (OCD) and Steve Mason (BLM) on 3/27/13.
