D.J. Simmons, Inc. completed the following Plugging and Abandonment procedure on the subject well:

- 2/28/2013 Move in and Rig Up well service unit.
- 2/28/2013 Trip out of hole and lay down rods.
- 3/1/2013 Trip out of hole with production tubing.
- 3/1/2013 Load bradenhead with 2 ½ bbls water and pressure test to 300 psi, held OK.
- 3/1/2013 Pump 35 bbls ahead at 3 bpm and 0 psi, mix 10sx (11.8 cuft) lead cement with 2%CaCl2, ¼#/sx cellophane to 15.6 ppg followed by 38 frac balls followed by 124sx (151 cuft) cement with 2%CaCl2 and ¼#/sx cellophane to 750psi. Wait overnight.
- 3/4/2013 Cut off wellhead. Cement down 60' in casing and 85' in bradenhead. Top off strings with 32sx (37.8 cuft) 15.6 ppg cement and set dry hole marker.
- 3/13/2013 Location clean and ready for remediation.
