Logos Operating, LLC proposes to commingle the referenced well upon completion of the Gallup and Dakota intervals.

The allocations per zone will be established by using the stabilized flowback rates of each zone which will be isolated during flowback (anticipated to commence within the next two-three weeks). The stabilized flowback rates will be compared against the swab test data for each isolated zone. After the completion, Logos will isolate each zone and swab test the zones to ensure that the flowback data is accurate.


The pressures per zone are calculated based on data gathered during drilling and also data gathered during flowback. The Dakota pressure is at or above the water gradient. The Gallup pressure is below water gradient and is calculated at 0.4 PSI/ft.


