4/15/13 Notified Agencies, Troy Salyers (BLM) and Brandon Powell (OCD) - got returns during the suicide squeeze (7th squeeze on this well), but top of cement is still short (TOC @ 4900'). Plans are to perf just above the casing collar @ 4860' and squeeze 17 1/2 bbls (52 sx) Premium Lite and then run a CBL again to make sure the cement tied into the 7" shoe @ 4509'. Verbal approval was given by both BLM and OCD to proceed with 8th squeeze.
