ConocoPhillips Company will be conducting a pilot test on the subject well by installing a VOCinerator (combustor) on this well pad. This pilot program will be a 1 well test to see if we can reduce our VOC emissions to comply with the new requirements being proposed by the EPA.

We will be adding this combustor to this well's facilities. See the attached drawing that indicates the placement of this piece of equipment. The dimensions of the combustor are approx. 24" in diameter by either 14 or 19' tall and for safety reasons will need to be placed at a minimum of 35' from the tank.
