Following plugging and abandonment done in 2001, the landowner was to have assumed ownership as a water well and provided documentation to that effect. However, due to the lack of progress in that area, Four Star Oil & Gas has decided to complete the plug and abandonment process to include the fresh water zone.

- Pump remainder of CMT. Sting out of retainer and pump 15 sks of CMT on top of retainer. Pull up and reverse circulate clean up tubing and TOOH.
- Pull up hole 50' and set a CMT plug 8 sks CMT. TOOH. ND BOP cut of wellhead, top fill with CMT. Weld on dry hole marker.
- RDMO.





CONDITIONS OF APPROVAL

1. Plugging operations authorized are subject to the attached "General Requirements for Permanent Abandonment of Wells on Federal and Indian Lease."
2. Farmington Office is to be notified at least 24 hours before the plugging operations commence (505) 564-7750.
3. The following modifications to your plugging program are to be made:
 - a) Place a cement plug from 2138' – 2038' to cover the Nacimiento top inside and outside the 5 ½" casing.
 - b) Place the Surface Casing Shoe plug from 280' – 180'.

You are also required to place cement excesses per 4.2 and 4.4 of the attached General Requirements.
