- Move in and Rig Up well service unit
- Pressure test temporary abandonment CIBP at 1053' to 500psi
- Mix and spot 78 sx cement to 15.6 ppg from CIBP at 1053' to fill well with cement to surface in 10 tubing joint increments. Each spot should be 23 sx. There are no gaps between cement planned.
- Remove wellhead
- Move rig out
- Dig out, cut off, install above grade marker, remediate location as indicated in conditions of approval




