MIRU D&D rig spud well on 5/28/13. 5/29/13 drilled 12 1/4" hole to 136' KB. Ran 8 5/8" 24# casing, landed at 134.70 KB. Ran centralizers on bottom joint, and every joint above. Pumped 105 sks of Premium cement with 2% CACL, and .125lb/sk Poly-E-Flake, 122.85 cf (wt 15.8#, yield 1.17). Dropped plug, displaced with 6.3 bbls fresh water. Returned 8 bbls cement to surface. WOC 20 hours.
