Test BOP to 3000psi for 30 minutes and 9.625" casing to 1500psi for 30 minutes on 5/24/13. No pressure drop. Started drilling out cement on 5/25/13 at 462'.

Set intermediate casing string 5/28/13 and cemented 5/29/13. Gelled freshwater mud system.

Hole diameter: 8.75", casing diameter: 7", casing weight and grade: 26# J-55 LTC. Depth of 8.75" hole from 0 to 5326'MD. Intermediate casing set from surface to 5269'MD. Stage tool at 1447'. Top of float collar at 5224'MD. TOC at surface and BOC at 5269'MD.

Cement: (Pumped 5/29/13) Lead: 400 sks Premium Lite FM + 3% CaCl2 + 0.25/sk Cello Flake + 5#/sk LCM-1 + 8% Bentonite + 0.4% FL-52A + 0.4% Sodium Metasilicate. Mixed at 12.1 ppg. Yield 2.13 cuft/sk. Tail 200 sks Type III Cement + 1% CaCl2 + 0.25#/sk Cello Flake + 0.2% FL-52A. Mixed at 14.6 ppg. Yield 1.38 cuft/sk. 20bbbls circ to surface. WOC 15.5 hours.

BOPs and casing tested to 1500psi for 30 minutes on 5/30/13. No pressure drop.

Drilled out DV tool (tagged at 1471') on 5/30/13. Started drilling out cement on 5/30/13 (tagged at 5223').
