Hole diameter: 12.25", casing diameter: 9.625", casing weight and grade: 36ppf J55 LTC. Depth of 12.25" from 0'-535'. Casing set from surface to 523' TVD/MD.

On 6/6/13 pumped 224 sks Type III cement, 0.25# per sk cello flake, 1% CaCl₂, 1% FL52A. Circulated 12 bbls cement to surface. WOC 12 hours for surface casing.

Float collar at 477'. TOC at surface and BOC 523'.

Tested BOP 6/6/13. Pressure held to 3000# for 30 minutes. Casing tested 6/6/13. Pressure held to 1500# for 30 minutes. No pressure drop. ✓

Started drilling out cement at 467'TVD/MD on 6/7/13.
