On April 20, 2013, ran 4 1/2 inch bull plug, 5 joints of 4 1/2 inch, 11.6 lb casing for sand trap, desander, Electric Submersible Pump (ESP) assembly, 102 joints of 3 1/2 inch, 9.3 lb, J55 NEW API tubing and 1 joint of 2 7/8 inch, 6.5 lb NEW API tubing. Bottom of string at 3417.5 ft KB, ESP pump intake at 3193.7 ft KB.

On May 10, 2013, commenced high volume lift production.
