Set surface casing string 6/6/13. Gelled freshwater mud system.
Hole diameter: 12.25", casing diameter: 9.625", casing weight and grade: 36ppf J55 LTC. Depth of 12.25" hole from 0'-525'. Casing set from surface to 516'TVD/MD.
On 6/6/13 pumped 250 sks Type III Cement + 25#/sk Celloflake + 1% CaCl2 + 0.2% FL52A. Yield 1.38 cuft/sk. Mixed at 14.6 ppg. 15bbls circ to surface. WOC 13.5 hours for surface casing.
Top of float collar at 469'. TOC at surface and BOC at 516'.
Tested BOPs and casing 6/7/13. Casing tested to 1500# for 30 minutes. No pressure drop. BOPs held to 3000#, no pressure drop.
Started drilling cement at 470' on 6/7/13.
