a. 185sks Type G Cement + 0.04% static free + 0.9% CD-32 + 0.005 gps FP-6L + 1% R-2. Mixed at 17.5 ppg. (.094ft3/sk yield). WOC 10.5 hours.

b. Spot tuned spacer

2. Pull uphole and reverse out

3. Pump bottoms up 2 times, pull uphole

4. Tag plug at 5200', continue to set 2nd kick plug

Set 2nd plug

1. Spot 2nd kick plug from 4750'-5200' on 6/13/13

a. 201sks Type G Cement + 0.04% static free + 0.9% CD-32 + 0.005 gps FP-6L + 1% R-2. Mixed at 17.5 ppg. (.094ft3/sk yield). WOC 8.25 hours.

b. Spot tuned spacer

2. Pull uphole and reverse out

3. Pump bottoms up 2 times, pull uphole

4. Tag plug at 4750' on 6/13/13
