

- MIRUPU. NDWH. NUBBOP.
- TIH w/ tbg. & spot a balanced plug of 50 sx of fine grained cmt. across lower leak and squeezing.
- TOH w/ tbg. & PU CR & set roughly 50' above 3038'.
- Squeeze upper leak w/ 200 sx of Type 3 cmt.
- WOC. TIH and drill cmt.
- Pressure test to 600 psi for 30 minutes making sure to chart test.
- Continue w/ scheduled Frac.
