Elm Ridge Exploration CO LLC has drilled a 7 7/8" hole to a TD of 7613' as of 7-11-13. On 7-14-13 we set 181 jnts of 5 1/2" 15.5# J55 casing was set at 7600'. First stage cement was as follows: Lead with 245 sks Halliburton Premium Cement. Tailed in 360 sks of 50/50 POZ cement and circulated 50 bbls good to surface. Second Stage: Lead with 900 sks of Halliburton Premium Cement. Tailed with 50 sks of Premium Class G cement and circulated 75 bbls of good cement to surface. DV tool was set at 5100'. Pressure tested the well to 1400 PSI. Released rig on 7-15-13. ✓
