

Dear Mr. Higgins:

Reference is made to the following wells located in the Rosa Unit, Rio Arriba County, New Mexico:

- 1) No. 393A, 2605' FSL & 2520' FEL sec. 15, T. 31 N., R. 4 W., lease NMSF-078892.
- 2) No. 500, 990' FNL & 970' FWL sec. 23, T. 31 N., R. 4 W., lease NMSF-078893.

The subject wells were approved for temporary abandonment until August 1, 2013 to evaluate. To date we have not received your plans for the above-mentioned wells.

You have 30 days to comply with this order. The 30 days commences upon receipt of this letter or seven days from the date it is mailed, whichever is less. Failure to comply within the 30 days may result in an assessment in accordance with 43 CFR 3163.1.

Under provisions of 43 CFR 3165.3, you may request an Administrative Review of the orders described above. Such request, including all supporting documents, must be filed in writing within 20 business days of receipt of this notice and must be filed with the State Director, Bureau of Land Management (NM-93000), P. O. Box 27115, Santa Fe, New Mexico 87502-0115. Such requests shall not result in a suspension of the order(s) unless the reviewing official so determines. Procedures governing appeals from instructions, orders or decisions are contained in 43 CFR 3165.4 and 43 CFR 4.400 et seq.
