Elm Ridge Exploration Co LLC spud the above referenced well on 8-10-13. On 8-11-13 we drilled a 12 1/4" hole to 525' and ran 12 joints of 8-5/8" 24# J-55 casing to 523'. We then pumped 370 sks of Premium Class G cement. Circulated 30 bbls of good cement to surface. Pressure tested casing to 600 PSI for 30 plus minutes. Test was good. ✓
