- 8/12/2013 MI A-Plus Rig #5. RU. TOOH, tallying 76 jts. of tbg. TIH.
- 8/13/2013 Tested the bradenhead to 300 psi. Held ok. Added subs. Tagged CIBP @ 2510'. Rolled the hole. Pmpd. 45 sx. (53.1 cu. ft.) CI B cmt. cont. 2% Ca Cl2. Pulled up to 1079'. WOC. TIH. Tagged cmt. @ 1987' (Plug #1 2510' - 1987)*. Pulled up to 1177'. Tested csg. to 800 psi and bled off to 770 psi. Retested twice with same result. Pmpd. 15 sx. (18.9 cu. ft.) CI B cmt. Pulled up to 195'. WOC.
- 8/14/2013 TIH. Tagged cmt. @ 997' (Plug #2 1177' - 997'). Pulled up to 425'. Pmpd. 45 sx. (53.1 cu. ft.) CI B cmt. from 425' to surface (Plug #3). POOH. Topped off with 45 sx. CI B cmt. and set the dry hole marker. RD and MO A-Plus Rig #5.
