4/22/13 Began acidizing @ 8 BPM rate. Discovered perfs were shot out of zone. Displaced acid out of csg w/166 bbls of 2% KCL. SI well. Release rig.

7/2/13 MIRU. RD frac stac. RU BOP. TIH, set packer @ 3942'. PT csg to 500#, good test. Release pkr and TOOH.

7/3/13 RIH w/4.50" cement retainer, set @ 3938', sting out of retainer. Perform squeeze job. Pumped 48 bbls 14.6 ppg Type III Neat cmt @ 2 BPM/1182#, cmt @ perfs 2.4 BPM/570#. POOH w/1 std of tbg. Reverse circulate. TOOH w/tbg. WOC.

7/5/13 TIH, tag TOC @ 3920'. Drill out cmt from 3920'-3940'. SI well.

7/8-10 TIH, tag cmt @ 3940'. Drill out cmt to 4005'. Circ clean.

7/11/13 TIH, tag cmt @ 4005'. Drill out to 4032'. Circ clean. TOOH. TIH, tag CBP @ 4160'. TOOH. Pressure up on csg to 610#, chart pressure test, held 30 min., loss 5# in 15 min, last 15 min pressure held at 600#, good test.

7/12/13 Prepare to perforate for PC Payadd.
