Set 19 external swellable casing packers for isolation of production string at the following depths: (1) 10,794' (2) 10,545' (3) 10,299' (4) 10,051' (5) 9801' (6) 9553' (7) 9304' (8) 9065' (9) 8830' (10) 8588' (11) 8350' (12) 8099' (13) 7852' (14) 7622' (15) 7390' (16) 7156' (17) 6920' (18) 6688' (19) 6460'.
