Two plumes left location. The North plume impacted a small water course at the end of the plume for approximately 165 feet. The south plume exited the southwest side of location and entered a small water course traveling approximately 650 feet.



Describe Cause of Problem and Remedial Action Taken.*

Two releases occurred back to back. The first release was due to the high pressure relief valve located on the separator on the morning of 9/30/2013. The second release occurred between 6 PM on 9/30/2013 and 6 AM on 10/1/2013. The second release overfilled the production tank and failure of the stuffing box attached to the wellhead. Wellhead pressure during the morning of 10/01/2013 was 2200 psi.. A flow back line and tank have been attached to the wellhead and pressures are being monitored

Describe Area Affected and Cleanup Action Taken.*

The area affected was the well pad, the access road, and a small water courses southwest of the well pad. Mechanized equipment as well as laborers with shovels are to excavate impacted areas. Soil sampling of the impacted areas after excavation, will be witnessed by a representative of NMOCD.
