Elm Ridge Exploration Co LLC spud the above referenced well on 9-25-13. On 9-26-13 we drilled a 12 1/4" hole to 522' and ran 12 joints of 8-5/8" 24# J-55 casing to 522'. We then pumped 350 sks of Premium Class G cement. Circulated 20 bbls of good cement to surface. Pressure tested casing to 800 PSI for 30 plus minutes. Test was good. ✓
