Because this well has been out of compliance with 19.15.26.11.A(2) for a total of 8 years and casing integrity cannot be verified; an MIT is required to verify the casing integrity within 90days.

This well was converted to an injection well in 1974. Since the conversion no well work has been reported. A sundry detailing the work that was performed to place this well back on production and a current wellbore schematic are required within 30days.
