Energen Resources intends to plug off the recently added Pictured Cliffs zone and return the Mesaverde Production. Earlier this year, the PC was added to production, and despite all efforts, there is marginal gas production with excessive water production. Therefore, the plan is to TIH w/ a packer on tbg to establish injection into the PC (The CBP is still in the hole isolating the MV). Then, TIH with cmt retainer to 50' above the top PC perf. Once the CR is set, squeeze off roughly 100 sx of either Class 3 or Type G cement into the perforations. WOC. Drill or CR and cmt, the pressure test and chart to 600 psi for 30 min. If test is good, Drill out the CBPs and clean out to PBD. Return MV to production.
