MIRU Llaves Well Service. NU BOP. RIH with 4-3/4 bit, bit sub, 31-jts 2-3/8" tubing - tag fill @ 857'. Set PS - drilled to joint #43 - lost circulation. POH with 8-stds. Drilled to joint #48 - lost circulation - mix mud. Drilled to joint #57 @ 1785'. RIH to joint #60 @ 1878' - lost circulation- mixed mud. Hard to drill. Drilled to joint #62 @ 1940' - called BLM (Jim) was told to plug well from 1940' to surface. POH with work string. TIH with 62-jts @ 1940' - pump 72 sks cement from 1940' to 1258'. TOC @ 1258'. POH with 22-jts - bottom of tubing @ 1258'. Pump 63 sks cement from 1258' to 676'. POH with 20-jts - bottom of tubing @ 645'. Circulate hole clean with water. POH with rest of work string. RU wireline and perf squeeze holes @ 269' - could not break circulation to surface. Pump 30 bbls water. Talked with BLM was told to perf. squeeze hole @ 50'. Pump clean water - good circulation. Clean outside 5-1/2" casing with 10 bbls water. Pump cement down 5-1/2" casing into squeeze holes. Circulate to surface. Cut off wellhead.
