
Describe Cause of Problem and Remedial Action Taken.*

At approximately 8:00 am on 10/9/2013 contract gauger arrived on location to pull water off production tank and ready tank for sale. After draining water to 95 bbl BGT on location he mistakenly opened the drain valve completely and tagged it and then left location. At approximately 11:00 am release was discovered and Team Leader notified. 259 bbls of an oil/condensate mix was put on the ground. The release was completely contained within the unlined steel ring secondary containment area. 242 total bbls of fluid was recovered from this same area including the fluid in the 95 bbl BGT. An initial investigation has begun to determine the impact depth and proximity to groundwater. Awaiting laboratory results to determine future course of action.

Describe Area Affected and Cleanup Action Taken.*

The release was completely contained within the secondary containment. The location is currently shut-in.
