- It is believed that a casing leak has developed in this well. It is intended to proceed as follows:
- TOOH w/ production tbg. Run csg scraper through liner and casing. TOOH.
 - TIH w/ packer and bridge plug. Set bridge plug at 5450' to isolate the MV perms. Pick up 1 jt and set packer. Test bridge plug to 1000psi.
 - Test casing to 600 psi.
 - Use packer to isolate casing leak, if there is one. Establish injection rate and pressure into leak. TOOH w/ packer.
 - Set cement retainer 50' above top of leak.
 - Pump squeeze job. The volume and slurry type of the squeeze will be decided after the injection test. Sting out of CR, reverse circ and TOOH.
 - WOC.
 - TIH w/ mill and DC's. Drill out CR and cement.
 - Pressure test casing to 600 psi for 30 min. Chart test.
 - Drill out bridge plug, clean out to PBTD.
 - TOOH w/ mill, TIH w/ production tbg and return to production.
