- 10/11/2013 Ranch denied access due to rain. Shut down for weekend.
- 10/14/2013 Run Bit & scrapper through tight spots. Clean out to 6022'. Pulled up to 2330'.

- 10/16/2013 Attempt to run csg inspection logs, could not get below 2400'. Run csg inspection without calipers frm 6130' to surface.

- 10/18/2013 Run CBL and Csg inspection logs frm 5955' to surface. Severe csg leaks @ 2238' & 2250', 2346' to 2360' & @ 3133'. Csg restrictions @ 2250' to 236' prevent running csg patch as planned.
- 10/21/2013 Run tbg out of the derrick & rig dwn service unit. Tbg currently @ 5766', BP over Dakota perfs @ 5955'.
