
On August 26, 2013, Huntington Energy filed a TA extension for the above referenced well. It was then realized that the pressure chart for the above referenced well had not been filed when the Temporary Abandonment procedure was performed on June 26, 2012. The well was tested at that time and tested OK, but the chart was not sent. A pressure test/chart was then performed in October, 2013 and was mailed to the BLM and NMOCD.
