11-12-13: Rig up wireline truck and start perforating. Perforate from 7179'-7362'. Shot 354 holes total.
11-13-13: Rig up Halliburton and start acid job. Pumped 6500 gals 7 1/2% DI MCA acid w/ Musal, Iron Seq, Clay Stabilizer, Flowback Surf, and Double Inhibitor. **11-18-13:** Rig up Halliburton and start Frac job. Pumped 13592379 MSCF of N2. Pumped 70552 gal of 70Q Delta Foam frac fluid. Pumped 2619 sks of 20/40 CRC sand. Made small show of oil. **11-26-13:** Set 2 3/8" 4.7# J55 tubing at 7176'. Test well for 24 hours. Made 40 bbls of water with 1 bbl of oil. Tubing pressure was 80 and casing pressure was 420. Well is currently on a 5/8" choke. 6466
